# ANNUAL REPORT OF THE NATIONAL REFERRAL MECHANISM FOR THE PROTECTION OF HUMAN TRAFFICKING VICTIMS (JANUARY - DECEMBER 2022)

The present Report for the year 2022 includes the data extracted by the Reporting Forms and the Protection Services' Monitoring Forms<sup>1</sup> for the period from 1/1/2022 until 31/12/2022, submitted to the National Referral Mechanism for the Protection of human trafficking victims (NRM) from January 1st, 2022 to January 31st, 2023, by the participating Actors.

The NRM management team in EKKA continued to receive information from the NRM participating Actors, in a remarkably accelerated pace in comparison to that of the previous years (reporting of new cases more than doubled), a development that may be linked to various factors, such as changes in the internal functioning of the stakeholders, the fact that even more professionals get familiarized with the phenomenon etc., but which in any case demonstrates the stability of the cooperation that has been built and sustained within the Greek NRM framework.

Also, the NRM management team has prepared:

- 1. The "Identification and Protection of Human Trafficking Victims Practical Guide for Frontline Professionals", which is being currently translated in English to be published both in Greek and in English [available on line here: Practical Guide for Frontline Professionals (Greek)]
- 2. Informational video spots regarding Human Trafficking in Greek, English, French, Romanian and Bulgarian language.
- 3. A leaflet of indicators for frontline professionals to be vigilant in identifying presumed victims of human trafficking during the reception of displaced Ukrainian citizens.

Meanwhile, the NRM management team in EKKA continued to implement training activities on the NRM tools and operational procedures, either independently or in the framework of other stakeholders' activities, as they are presented in the Annex. Furthermore, we achieved to include an educational seminar on the "Prevention and Combat against Human Trafficking - Protection of the trafficking victims", with special reference to the NRM operation, in the Programmes of the

Training Institute of the National Centre for Public Administration and Local Government (EKDDA); an outcome of several years of efforts. The seminar lasts three (3) days and is followed by a reflection workshop, ten days after the completion of the main training part. The interest already expressed for the initial EKDDA training has been significant.

For the first time we attempt to add a special Annex hereby, in order to present activities targeted especially to the anti-trafficking response and undertaken by state and non-governmental stakeholders during the reporting period, which aimed at the professionals' information and training, or to the victims' protection, enhancing their main work. This decision of both the Office of the National Rapporteur Against Trafficking in Human Beings (ONR) and EKKA is based on the conviction that NRM's mission is to support the stakeholders and the professionals in their work and highlight their contribution in the human trafficking victims' protection.

\*\*\*

The data included in the present report regard victims that were either detected within 2022 (new cases), or/ and received protection services (as trafficking victims) during the reporting period.

The data were derived from:

a. the reports for trafficking victims that were detected and/or received protection services in the country from January 1st 2022 **until December 31st 2022**, as well as

b. the procedure of monitoring the cases of the victims that were reported to the NRM within 2019<sup>2</sup>,2020<sup>3</sup> και 2021<sup>4</sup> and continued to receive services during the reporting period (2022).

More specifically, during the NRM's first year of operation, in 2019, 154 reporting forms for presumed and recognised human trafficking victims were received; in 2020, 167 cases of presumed and recognised victims were reported, while in 2021, 157 cases of presumed and recognised victims were reported. During 2022, one hundred and two (102) cases of the three previous years

remained «open» - seventy-eight (78) of adults and twenty-four (24) of children - as they continued to receive protection services. In **Part A** of this report brief data of these cases are presented.

\*\*\*

It is reminded that human trafficking victims<sup>5</sup> are reported to the Mechanism, *regardless* of whether trafficking took place within or outside Greece and independent of the time the trafficking crime was perpetrated. The main goal of the report to the NRM is the depiction of the protection services provided to each presumed or officially recognized human trafficking victim, in a way that ensures the most complete protection possible.

According to the NRM Standard Operating Procedures (SOPs), following the receipt of a Reporting Form and provided that the adult victim has given consent to be registered in the NRM<sup>6</sup>, EKKA provides a Registry Number and monitors the case, not only to capture the referrals and services provided, but also to ensure the continuity and sufficiency of these services.







## PART A: VICTIMS OF HUMAN TRAFFICKING WHO CONTINUED TO RECEIVE SERVICES IN 2022


As mentioned above, a total of 102 cases of the last three years (2019-2021), remained "open" during 2022, and include seventy-eight (78) adults and twenty-four (24) children, victims of human trafficking.

Their demographic data of the victims reported to the NRM in 2019, 2020 and 2021, that continued to receive services in 2022, are depicted in the following graphs:






It is noted, that **one (1) trans woman** has been registered with the (male) sex assigned at birth.












The countries of Africa include: Côte d'Ivoire, Somalia, Togo, Cameroon, DR Congo, Ghana, Gambia, Burkina Faso, Nigeria, Uganda, Mali, Congo, Senegal, Guinea, Morocco and Sierra Leone. The countries of Asia include Pakistan, Afghanistan, Iran, Syria and Bangladesh. Four (4) victims originate from Romania. The victims from European countries outside the EU come from Moldova and Albania.




The countries outside the EU include Moldova and Albania. The child victims from other EU countries originate from Bulgaria and Romania. The Asian countries include Pakistan, Bangladesh and Iraq. The child victims from Africa originate from Morocco and DR Congo.

In total, the "open" cases of 2019, 2020 and 2021 continued to receive **in 2022** the following services:










The range of services that victims keep receiving, shows their multi-level needs, as well as the long period needed for those to be covered. It is certain, however, that the services, even regarded as of 1<sup>st</sup> level, do not aim over time to cover urgent needs, but they are redefined in order to support the victims during their social integration.

Half of the accommodated adult victims are still staying in facilities of temporary protection of the Reception and Identification Service.










More specifically, the services that the **child victims** continue to receive in 2022 – depending on their current needs - are accommodation, legal counselling and representation, psychological and social support, education (schooling and Greek lessons), medical care and material assistance. The accommodation is provided almost exclusively in hosting structures for unaccompanied minors or other child protection facilities. It is noted that there was no data of supporting in the appointment of a guardian.


Many services are provided to the victim escorted by a professional, in order to ensure or facilitate the access to those services. The "escorting" service was provided in five (5) cases for the provision for social support, in three (3) cases during the legal representation and in thirty-three (33) cases for the provision of medical assistance. In the last case it seems that the professionals regarded escorting as necessary, mainly for the facilitation of the communication with the medical staff and the nurses – especially when interpretation is not available and in order to settle possible procedural issues (scheduling a new appointment etc.).

















Regarding the residence status of the aforementioned victims, according to the updated services monitoring forms received by NRM, eight (8) of those reported in 2021 as asylum seekers received the international protection status in 2022, though not necessarily on the ground of human trafficking. On the contrary, three (3) victims who were registered as asylum applicants in 2021, are currently without legal documents.

Lastly, three (3) victims who were reported to the NRM in the previous years, were been formally recognised as human trafficking victims (with the issuance of an act by the competent Public Prosecutor) during the reporting period.

No case of safe and voluntary return or resettlement to a third country was reported for the victims registered during the previous years.

### **PART B: NEW CASES OF 2022**

The general picture, depicted by the data regarding the new cases of 2022, does not differ much from that in the previous years. Although the encouraging expansion in the actors who have reported to NRM continues, the largest number of reporting forms keeps coming from the same state partners. This, of course, can be attributed to the close and direct linkage of their responsibilities with the procedure of identifying victims of trafficking, while this does not apply exclusively to them. Additionally, it is noticed that the systematization of the information flow regarding the services received by the victims is gradually improving, with the desired goal to capture a more accurate picture of the related issue. At the same time, we sought to resolve the difficulty of monitoring the cases identified by the Asylum Service, specifically the victims residing in Reception and Identification Centres on the islands who were moving to mainland, as there were cases that EKKA had not been able to follow up on the protection they may receive from there on (Actor and type of services). Therefore, through cooperation with co-competent Bodies (Asylum Service and First Reception and Identification Service), the standardized procedures were reformed in a way that ensures continuation of monitoring for each case reported.

Regarding the assessment of the pandemic's effects of on the way perpetrators act, as well as on the general situation of the victims, the data submitted to NRM does not lead to any specific







conclusion (as in the previous year), apart from the fact that many Actors continue to make use of the online communication with the victims as an alternative solution and a good practice that was initiated mainly as a communication channel with them during the pandemic.

The number of reports sent to NRM during the year 2022 **reached three hundred and fifty-eight (358)**. They were sent both from services of the Public Sector, which, however, have not been differentiated from previous years, as well as from Actors of Civil Society.

In particular, two hundred and fifty-nine (259) reports were sent by the following Actors of the Public Sector:


### 1. DEMOGRAPHICS OF TRAFFICKING VICTIMS - NEW CASES 2022


### I. Gender

Out of the total number of new cases - three hundred and fifty-eight (358) - in the year 2022, two hundred and ninety-three (293) concern women and girls (including one -1- trans woman and one -1- trans girl) and sixty-five (65) men and boys. There were also reported. It is found that the majority of both adult victims and children are women and girls, respectively. From women, fourteen (14) were pregnant when the report was submitted, while sixty-five (65) reside with their children in Greece. Also, two (2) minor girls were pregnant during the submission of the report to NRM.

From child victims, the unaccompanied were a total of forty-three (43), seventeen (17) boys and twenty-six (26) girls.

The graphs depict the gender that was assigned to them at birth.












# II. Age

Regarding victims' age, the majority of adults are below 35 years old. Sixty-eight (68), out of three hundred and fifty-eight (358) reported trafficking victims, are children.










## **III. Nationality**




The countries of Africa include Sierra Leone (72), DR of Congo (41), Cameroon (40), Eritrea (20), Ethiopia, Ivory Coast, Gambia, Ghana, Guinea, Congo, Kenya, Mali, Morocco, Mauritania, Burkina Faso Nigeria, Uganda, Senegal, Somalia and Togo. The countries of Asia include Afghanistan, Iran, Bangladesh, Nepal, Pakistan, Syria and Yemen. The victims from non-EU countries are from Albania and Moldova. The victims from other (than Greece) EU countries are from Romania. In the countries of Caribbean, the Dominican Republic and Cuba are included.









The countries of Africa include Somalia, Ivory Coast, Cameroon, Sierra Leone, Guinea, DR of Congo, Ethiopia and Burundi. The Asian countries include Pakistan, Iran and Bangladesh. European countries outside EU include Albania while the other EU countries include Bulgaria and Romania.

The majority of unaccompanied children are from Somalia (24 girls and 4 boys), followed by 7 boys from Pakistan and fewer children from Ivory Coast, Bangladesh, DR of Congo, Sierra Leone, Guinea, Cameroon and Burundi.








## IV. Residence status

The vast majority of adult victims registered to the NRM and currently receive protection services have applied for asylum and is awaiting the examination of their claim. The high number of asylum applicants reported is related to the systematic psychosocial assessment that is carried out within the Reception and Identification Centres and the Closed Controlled Access Centers in Aegean Islands, as well as the stable and active participation of the Asylum Service in the NRM.




And in the case of child victims, the majority of them are asylum seekers, as the 39 out of the 43 unaccompanied children who were identified as presumed victims of human trafficking.









During the year, **forty-four (44)** persons were granted **international protection status**, of which thirty-nine (39) were initially reported to the NRM as asylum seekers, four (4) as holders of a police note and one (1) as lacking legal documents. Also, four (4) victims who lacked legal residence permit applied for asylum during the year. On the contrary, the residence for 4 (four) of the applicants/asylum seekers, became irregular during the reporting year, i.e., they received final rejection and they did not obtain - within the year – any other title of legal residence.


## V. Educational level

The educational level of adult victims registered in the NRM is captured in the graph below, with the majority having completed primary school while the percentage of those who have never been to school is also large.


















It should be noted that the graph above representing the education level of child victims only includes school age children, who are 6 years old and over. Ten (10) child victims were under 6 years of age.

## VI. Place of residence in Greece upon detection

It is reminded that the reference to the place of residence - as well as the residence status - of the victims refers to the period they were detected and reported to the NRM. As it is seen in the graph below, the residence in most of the cases of adult victims is within the framework of the asylum applicants' reception (RICs, Closed Controlled Access Centers and accommodation facilities managed by NGOs within the framework of the ESTIA Programme)









It must be noted that in the Reporting Form, the indication of the accommodation provision by the exploiter has been added, so that these cases can be reported separately, for a more accurate capture of the exploitation history, since this information concerns the action of harboring, while the victim is still being exploited.

A typical example is the reporting of the place of residence for the children, who at the time of their identification were still under exploitation, mainly for forced begging. The majority of children seem to reside in apartments rented by their escorts – allegedly their parents and in which, as reported to the NRM, more families might reside there as well. These cases, in 2022, were fifteen (15).









It should be noted that with the article 43 of law 4760/2020 (A' 247) in force since December 2020, unaccompanied minors who are deprived of safe or known residence are no longer placed in protective custody foreseen by the article 118 of PD 141/1991 (A' 58).

For the operational implementation of the legislative abolition of protective custody, the Special Secretariat for the Protection of Unaccompanied Minors of the Ministry of Migration and Asylum, the UN High Commissioner for Refugees and Child Protection Actors, in cooperation with Prosecutors and Police authorities, established the "National Emergency Response Mechanism for unaccompanied minors" in precarious living conditions, which was implemented in April 2021.








#### 2. TRAFFICKING ACTS

The following graph depicts the trafficking acts that took place, as derived from the history of victims reported to the NRM. We should note that in every case more than one acts may have taken place as indicated below (e.g., recruitment, followed by transport and reception and harbouring).



It is interesting that the actions of recruitment and harboring are very common, while in the case of adult victims, cross-border transportation and reception follow with a slightly lower frequency. The highly frequent recording of harboring, i.e., providing space for the victim to live in so that they remain available for exploitation, is indicative of its effectiveness in relation to the control of the victim by the perpetrator. At the same time, the combination of the findings of cross-border transportation and the high number of asylum seekers is linked to the cross-border dimension of human trafficking, which follows migration/refugee routes.









### 3. INFORMATION ON RECRUITMENT

## **I. Country of Recruitment**

The recruitment is one of the basic elements of human trafficking, which must be examined in depth, as it helps us to better understand the phenomenon. The recruitment means, along with the purpose of exploitation, reveal important information that can help the early identification of a victim and can be used for the prevention of the crime, through bringing awareness to vulnerable groups so that they can avoid being trapped during recruitment attempts.

Similar to previous years' findings, the recruitment in most cases took place in the country of origin. The category «Greece» refers to cases of citizens of other countries that were recruited in Greece and not victims of Greek citizenship, who are included to those recruited in their "Country of Origin".









Eighteen (18) - 10 girls and 8 boys - out of the thirty-seven (37) children recruited in their country of origin were of Greek nationality who were recruited in Greece. This is not the case for the adults who were recruited in their country of origin (one hundred and fifty-five (155), out of which only five (5) - 4 women and 1 man - were of Greek nationality that were recruited in Greece.

It is also interesting that the number of victims recruited in Turkiye during their journey to Europe, representing 27% of adult victims (34 out of 125) and almost 70% (15 out of 22) of children victims who are recruited in countries other than their country of origin and Greece.










### II. Means of recruitment

It should be stressed that more than one means of committing the acts is used, and specifically that of the recruitment act. It is also observed that, in cases of adult victims, during recruitment the means of deception comes second, with a very minor distance from the means of exploitation of the vulnerable situation. This might mean the combination of those two in several cases. It seems, therefore, that the vulnerable state in which the victims are already, is what makes their recruitment easier for the perpetrators.










The following graph depicts data that regard child victims, even though in their case, **the detection of trafficking means is not required**. Nevertheless, the relevant data is useful for understanding the specific ways of action during children's recruitment. It is obvious that childhood is by definition a vulnerability exploited by the recruiters, while the "abuse of power" is connected to the exploitation by the parents, mainly in cases of exploitation of begging.










# III. Information on recruiter/s

The following graphs depict information regarding the profile of the recruiters and their relation to the victims. In 89 cases (79 adults and 10 children) out of the 357 that recruitment was noted as an act, the recruiters were two (2) persons.

















In adult victims, the majority of recruiters are men, while in children the numbers are the same for men and women, which can be attributed to the fact that in many cases the recruiters are family members - both parents (30) or their relatives (20) – as shown in the "Relationship between the recruiter and the Child Victim" chart below.










This graph shows how often the nationality of the victim is the same as the nationality of the recruiter. This finding is in alignment with the finding that recruitment often takes place in the country of origin. One could say that it is more common (as it is easier as well) for a victim to be approached for recruitment by a co-national.




Regarding the relationship of the recruiter/s with the adult victims, it seems that for a percentage higher than 50%, those were not persons unknown to the victim. In seventy-nine (79) cases of adults' recruitment, two (2) recruiters were mentioned. Respectively, ten (10) reported cases of child victims, had two recruiters.










The following graphs show the structure of the roles of the people involved in the crime. In most of adult victims' case, perpetrators appear to play more than one role, with the majority of them also involved in the victims' transfer (mainly cross-border). On the other hand, in the case of child victims, it appears more frequently that the recruiters end exploiters are the same persons which leads to the conclusion of operating as non-organized groups, as these have separate roles for all involved.












In most of the cases, as shown in the graph below, the relationship between the recruiters either remained unknown to the victim (thirty-four, 33), but in most cases the recruiters knew each other<sup>7</sup>.



## 4. INFORMATION ON EXPLOITATION

In the majority of cases (317), the victims (259 adults and 58 children) were exploited for the first time. In thirty-three (33) cases, their reported exploitation was not the first one to ever take place (including 5 children). In eight (8) cases (3 adults, 5 children) the relevant information remains unspecified.








## I. Forms of Exploitation

Sexual exploitation remains the main form of exploitation in the NRM reported cases. In thirty-five (35) cases, the victims were subjected to multiple forms of exploitation. Among the adult victims' cases, where multiple forms of exploitation were reported (29 cases in total), there were twenty (20) referring to sexual and labour exploitation (agricultural and industrial sector, domestic work/care of persons, touristic sector, servitude and slavery<sup>8</sup>).



Among the total of cases, exploitation of begging was reported along with sexual exploitation in three (3) cases. Labour exploitation was reported along with exploitation of begging in one (1) case, with forced marriage in three (3) cases. Lastly, in one case both labour exploitation and forced criminality were reported an in another one (1) labour exploitation and removal of organs.

In the case of child victims (a total of 6 cases of multiple forms of exploitation), in four (4) cases both labour exploitation and forced marriage were reported. In one (1) case, sexual exploitation was reported along with domestic labour, while in another case the removal of organs was reported along with labour exploitation.


# II. Victims' biological sex/age per Form of Exploitation

As shown in the graphs below, sexual exploitation concerns mostly women and girls both in adult and child victims' cases, confirming its categorisation as a form of gender-based violence.










In the case of child victims reported to the NRM, the largest percentage concerns girls, victims of labour exploitation, as well as of the exploitation of begging.



#### III. Means of control


Based on the data recorded, it is observed that in most cases more than one means of control have been used during exploitation, with coercion and exploitation of vulnerability being the most common ones. Nevertheless, in the case of children, another commonly used means of control is the abuse of power, strongly linked to their exploitation by relatives, as shown below.








All information provided in relation to the means of recruitment of child victims (see above), also applies in the case of the means of exploitation used against children.













# IV. Information on the exploiter/s

The following graphs provide information on the exploiters' profile, as well as their relation to the victims.



While, in the initial phase of recruitment, it seems that the predominant trend is to approach the victim while being in a vulnerable situation, with a covert and seemingly non-violent way (deception by co-nationals), in the phase of exploitation, coercion is most often



used as a means of control, in order to force the victim to cooperate, since at that point the victim has obviously realised the real purpose of the exploiter(s). During that stage, the









percentage of perpetrators is almost shared among those of different nationality from the victim's and those that are co-nationals.

In ninety-one (91) cases, there were two (2) persons referred as exploiters (76 cases of adults and 15 cases of children). Most cases reported, that nationality is common among victims and exploiters, refer to those of child exploitation of begging by the (alleged) parent or (alleged) relative.















In the majority of adult victims' cases, the exploiter/s is/are completely unknown to the victim.





In the majority of the cases that there was more than one person involved in the exploitation and the victim was able to provide information on their relation, the two exploiters were reported as spouses/partners.











# V. Countries where the exploitation took place

It should be noted that most adult victims detected during 2022 were exploited abroad; the vast majority refers to cases of exploitation within the context of migration routes, especially








those having taken place in Turkiye (as shown in the graph below). According to data on recruitment trends, it becomes apparent that recruitment often takes place in Turkiye; however, the graph below shows that, as a country where exploitation can take place before the victims' arrival in Greece, Turkiye outnumbers all other countries recorded.

It is, also, clarified that under the indication of the 'country of origin' 4 women and 18 children of Greek nationality are included in the respective graphs.

Therefore, a total of fifty-three (53) persons -26 adults, of which 4 are Greek nationals, and 27 children, of which 18 are Greek nationals- have been identified as victims whose exploitation took place in Greece. It is noted that one (1) victim of Greek nationality was exploited abroad.




In the case of children, a domestic trafficking trend (i.e., in their country of origin) has been recorded, which is also present – though to a lesser extent - in the cases of adult victims.










The following two graphs show cases of victims – both adults and children – whose exploitation took place either in Greece or in Greece and abroad (*in the latter case, the form of exploitation reported is the one that took place in Greece*). It is reminded that the forms of exploitation having taken place could be more than one in each case.


In light of the above, the most common form of exploitation among children, regardless of their biological sex, continues to be the exploitation of begging, while in the case of adult victims it is sexual exploitation for women and labour exploitation for men.












Regarding the most common forms of exploitation that have taken place outside Greece, the picture remains the same; sexual exploitation has been mostly recorded for women's cases, while labour exploitation for men's. In terms of child victims exploited outside Greece, labour exploitation has been recorded as the most common form of exploitation for both boys and girls. More specifically, in the case of unaccompanied children, only four (4) boys, out of a total of 43 children, have been subjected to labour exploitation in Greece. The rest of thirty-eight (38) children








have been exploited, either in their country of origin (20 cases) or during the migration route (21), the majority in Turkiye (17 out of 21 cases) for labour exploitation.












# VI. Ways of escaping trafficking condition

Out of the three hundred and fifty-eight (358) victims reported to the NRM during the reporting period, the vast majority (three hundred and fifty-three - 353) have escaped the trafficking condition, while whether the victim continues to have no contact with their exploiters was declared unknown by the identification Actor in five (5) cases, at least until the reporting date to the NRM.












For the three hundred and fifty-three (353) victims - adults and children - who have escaped the trafficking situation (out of 358 in total), the ways of their escape were as follows:











There are more cases where the adult victim escaped alone, but the large number of children as well as adult victims who escaped with the help of a third party is worth mentioning, which demonstrates the need to continue and intensify efforts to raise public awareness of the issue, since citizens may even be instrumental in locating a victim. Important, without a doubt, was the intervention of the Authorities in freeing the child victims from the situation of trafficking.

# VII. Official recognition as victims of trafficking

The characterization as a victim of human trafficking is granted by a Public Prosecutor's Act. The number of new cases in 2022 that are in process of official recognition are only eighteen (18). The cases that are not under an official recognition process mainly concern victims who had been exploited in the past and in another country. It was not possible to further follow up on the cases that are included in the "Unknown" category, which probably concerns cases that have not entered the official recognition process. As already mentioned, in 2022, there were three (3) official recognitions of older cases of trafficking victims, but none of them regarded cases that were registered within the reporting period.

It is clear that the number of cases where characterization process has not been initiated is overwhelmingly greater. In cases of no criminal prosecution or unwillingness of the victim to cooperate with authorities, ONR and EKKA encourage all collaborating Actors to make use of the provision in the institutional framework, for the possibility of issuing an official recognition by submitting the written opinion of two professionals from Protection actors, to the competent Prosecutor's Office (no. 4 para. ia' L. 5038/ 2023).

Also, no cases where a reflection period was provided were reported.











It is noted that the issuance of official recognitions referred in this Report are those reported to the NRM by cooperating Actors. Only through the most direct possible cooperation of the local competent Prosecutor's Offices, who have the full picture of the cases under consideration, will contribute to having a complete picture in this matter. The cooperation of ONR and EKKA with the Prosecutor's Office of the Supreme Court is moving towards this direction.








#### 5. LEGAL PROCEDURES - VICTIM'S ACTIVE PARTICIPATION

#### Victim's consent to Cooperate with Police

The consensual cooperation with Police applies only to adult victims, during the identification stage. As in the previous years, there is a big number of reporting forms in which remains unknown if the victim has given consent to cooperate with the authorities, a fact that raises questions about whether this is related to the victim's difficulty in making this decision immediately or if it is a matter of non-prioritization of this issue, by the professional, working with the victim, since the majority of the victims have proceeded in the submission of an asylum request. However, while monitoring the ongoing provision of protection services to the victim, the question remains open, in case of any possible development on this.



#### **Participation of the victim in Criminal Proceedings**

In sixteen (16) of the cases that have been reported to the NRM, criminal proceedings are ongoing within the reporting year, while for one (1) case it was decided by the judicial council that adult procurement (and not human trafficking) had been committed, which at the time of execution was not penalized. Two (2) cases concern minor victims. In two (2) cases prosecutions







were brought for other charges, but not for trafficking. Finally, for six (6) cases where the Actor provided legal support, the contact with the victim was lost.

# 6. PROTECTION

# **Receiving protection services**

The following graph illustrates the number of victims that were reported to the NRM within 2022 (new cases) and the kind of protection services they received throughout the year, by the Actors that in the vast majority are integrated in the Mechanism.










Regarding the escorting of a victim to ensure or facilitate the access to services, it was provided in five (5) cases of Social Support services (i.e., school enrollment), in four (4) cases during legal representation and in twenty (20) cases of medical care provision.

Victims reported, in their majority were accommodated in camps (Reception and Identification Centers, Closed Controlled Facilities and Temporary Accommodation Facilities) of the Reception and Identification Service of the Ministry of Migration & Asylum, mainly where they were detected and identified as victims of trafficking.




In ten (10) child victims' cases, in the accommodation category the urgent admission to a Children's Hospital is also included, as an emergency protection measure after exiting the trafficking condition (mainly, after the intervention of the Authorities). After medical examinations as well as needs and risk assessment are carried out, the competent Prosecutor's Office is informed, in order to take further protection measures.


No relocation to a third country or return to country of origin for child victims were reported.


